Superintendent's Report:

- -Industrial Park: On Thursday, January 4, 2007, Denny and Perry met with Mark Harris and Dennis Severinsen representing MLG Commercial, which is a real estate company that markets commercial and industrial properties. The purpose of the meeting was to discuss the possibility of MLG Commercial listing the industrial park and trying to market it on a regional and nationwide basis. Both Severinsen and Harris inspected the site prior to the meeting and later went back with Denny to go over the boundaries of the property. MLG will be preparing an agreement for marketing the property in the next week or so.
- -Manufacturing Inquire: On Wednesday, January 3rd, Perry met with the owner of Iron Mountain Custom Displays about moving his operation to the Township. They are currently located in Iron Mountain and their facility is laid out poorly which limits the production of their product. They looked at various sites including the industrial park. The sites that were preferred were township property on Second Street, Menominee Street and property on the Breitung Cut-off and Hydraulic Falls Road.

-Trustees Dixon and Gaudette presented the Township Flag to the board. The board agreed with the design and it will be ordered immediately. It should be ready in time for the MTA Convention.
