NOISE ORDINANCE, LINCOLN STREET, BACCO  
425 AGREEMENT/ANNEXATION  
APRIL 3, 2007**

The meeting was called to order by Supervisor Olson at 7:00 p.m.

**Bacco bill:** The Township paid \$58,471.47 for the Quinnesec Street paving in 2006. Bacco has now submitted a bill totaling \$28,410.65 for extra work done for approaches and an alley that was not in the original specifications. Tim Hammill of the DCRC has negotiated the price down to \$16,872.87. The general consensus of the board is to look at different asphalt companies for future projects within the township.

**Noise Ordinance Issue:** Supervisor Olson met yesterday with Larry Gasperich of the State Police, Don Charlevoix & Scott Cellelo of the Dickinson County Sheriffs Department and Tim Hammill of the DCRC. Breitung Township needs to look at their excessive noise ordinance. The State Police will be running a Swap Team and giving out fix-it tickets.

**Lincoln Street:** The DCRC will be setting up monitors once again to gage the number of semi-trucks using that street and the speed of all vehicles. The State Police will be doing a traffic study and looking at the parking issue by the soccer & baseball fields.

**Motion** by Supervisor Olson, second by Trustee Erickson to close the special board meeting and enter into Executive Session to discuss pending annexation litigation. Ayes; Trustees; Gaudette, Wales, Dixon & Erickson, Supervisor Olson, Treasurer Cahee & Clerk Coron. **Motion carried.**
