Motion by Treasurer Cahee, second by Trustee Wales to allow Superintendent Franzoi to submit a preapplication for the spring Rural Development program for the total of \$8 million toward a lagoon system/sewer/waste water. **Vote: Unanimous, motion carried.**

- -Norway Sewer Discussion: On May 23 rd, Superintendent Franzoi spoke with Ray Anderson in detail about the possibility of getting sewer capacity in the Norway Treatment plant. Ray Anderson stated that the Utility Authority is ready to move forward with the request and they will be getting estimates for adding a clarifier to their plant to add capacity for the township.
- -Repairs to Well No. 3 have not yet been completed. We are still waiting for delivery of the new pump.
 -A copy of the revised buy sell agreement has been sent to KSR and they are in the process of reviewing it.
 When we have an agreement, the surveyor will be contacted and the Road Commission will survey the road portion of the property.

Board Discretionary Time:

-Trustee Dixon received a complaint on dogs doing their "job" at the East Kingsford Park. The board may have to look into posting signs. Also a compliment was received by Judy Gunville on how nice our parks are.
-Supervisor Olson informed the board that he has spoken with Tim Hammill from the Road Commission

-Supervisor Olson informed the board that he has spoken with Tim Hammill from the Road Commission regarding the parking concern we have by the soccer field and ball fields. The RC will be placing no parking signs along the fence. Also, on June 12th the Township Association meeting will be held at Gunville's Wilderness Ridge.
